RE: Waste Deliveries – Pa. Covered Device Recycling Act

The Waste System Authority of Eastern Montgomery County has been notified (See Attachment) by its disposal vendor, Covanta Energy, that as a result of the Covered Device Recycling Act (CDRA) (Act 108), as of January 24, 2013, it will no longer accept any covered devices or components of covered devices.

The notice identifies covered devices as including: Desktop computers, laptop computers, computer monitors and televisions. A complete list of covered devices may be found at www.depweb.state.pa.us, select "Electronics Recycling" from "DEP Programs A – Z" menu. More information on the CDRA may be obtained by calling the Recycling Hotline 1-800-346-4242.

For Waste System Authority customers this notice and the CDRA requirements mean that as of January 24, 2013, these devices should not be picked up for delivery to the Waste System Authority's entry points. These items will, of course, be accepted at the regional electronics waste drop-off events. The dates for these events have not yet been announced.

Thank you for your strict adherence to this new statutory requirement.
